# COMMISSION STAFF'S STATUS REPORT AND PROPOSED PROCEDURAL SCHEDULE

On December 3, 2020, Monarch Utilities I L.P. (Monarch) filed an application to amend its sewer certificate of convenience and necessity (CCN) 20899 in Chambers County, Texas. Monarch's application indicates that there are no customers in the areas proposed for decertification. Monarch filed supplemental information on February 17, 2021, April 29, 2021, June 14, 2021, September 24, 2021, and November 19, 2021.

On June 8, 2022, the administrative law judge filed Order No. 17, establishing a deadline of June 17, 2022 for the Staff of the Public Utility Commission of Texas (Staff) to file a status report regarding the provision of tariffs to Monarch for review and consent. Therefore, this pleading is timely filed.

# I. STATUS UPDATE AND MOTION FOR AN AMENDED PROCEDURAL SCHEDULE

Staff provided an updated tariff to Monarch on June 17, 2022. As such, Staff proposes to amend the procedural schedule as follows:

Event	Date
Deadline for Monarch to file signed consent forms with the Commission	July 1, 2022
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	July 15, 2022
If no hearing is requested, deadline for parties to file joint proposed findings of fact including findings that address the factors in Texas Water Code § 13.246(c), and conclusions of law	July 29, 2022

## II. CONCLUSION

Staff respectfully requests the entry of an order amending the procedural schedule.
