Shell Energy North America (US), L.P. ("Shell Energy") submits its semi-annual report pursuant to P.U.C. SUBST. R. 25.107 (i)(5)(B). Shell Energy additionally submits the affidavit of Marci Milner, Vice President – Regulatory Affairs, attesting to the facts represented herein. Shell Energy provides the following information as required under the rule.

- 1. Documentation to demonstrate ongoing compliance with the financial requirements of subsection (f) of this section. (SUBST. R. 25.107 (i)(5)(B)(i)).
 - a. Investment Grade Credit Rating (SUBST. R. 25.107 (f)(1)(A)(i)).

Shell Energy relies on its investment grade credit rating to demonstrate compliance with the financial requirements under the rule, and attaches the latest ratings from Moody's and Standard and Poor credit rating agencies. These are copyrighted materials and are therefore being submitted confidentially and under seal.

b. The amount of customer deposits and the balance of an account in which customer deposits are held (SUBST. R. 25.107 (f)(2)(B))

Shell Energy does not collect customer deposits or residential advance payments.

2. The audited financial statements of the REP or its guarantor for the most recent completed calendar or fiscal year. (SUBST. R. 25.107 (i)(5)(B)(ii))

Because Shell Energy has an investment grade credit rating, it is not required to submit audited financial statements. SUBST. R. 25.107 (i)(5)(D).

3. The unaudited financial statements for the most recent six-month financial period that immediately follows the end of its most recent fiscal year or six consecutive months of monthly financial statements. (SUBST. R. 25.107 (i)(5)(B)(iii)).

Because Shell Energy has an investment grade credit rating, it is not required to submit unaudited financial statements. SUBST. R. 25.107 (i)(5)(D).
