**ANNUAL REPORT OF TRAILSTONE ENERGY MARKETING, LLC**

TrailStone Energy Marketing, LLC ("TrailStone"), Retail Electric Provider ("REP") Certificate No. 10272, submits its annual report pursuant to P.U.C. Substantive Rule § 25.107(i)(5). TrailStone additionally submits the affidavit of Dennis J. Withee, Secretary, attesting to the facts represented herein, as well as filing confidentially all documentation related hereto. TrailStone provides the following information as required under the rule, and agrees in advance to submit any additional information as requested.

1. **Any changes in addresses, telephone numbers, authorized contacts, and other information necessary for contacting the certificate holder. (Subst. R. 25.107(i)(5)(A)(i)).** There have been no changes to this information.
2. **Identification of areas where the REP is providing retail electric service to customers in Texas compiled by zip code. (Subst. R. 25.107(i)(5)(A)(ii)).** TrailStone is not currently providing retail electric service to any customers.
3. **A list of aggregators with whom the REP has conducted business in the reporting period, and the commission registration number for each aggregator. (Subst. R. 25.107(i)(5)(A)(iii)).** TrailStone has not conducted any business with aggregators during the reporting period.
4. **A sworn affidavit that the certificate holder is not in material violation of any of the requirements of its certificate. (Subst. R. 25.107(i)(5)(A)(iv)).** This affidavit is included as a part of the confidential filing provided in Exhibit A.
5. **Any changes in ownership. (Subst. R. 25.107(i)(5)(A)(v)).** There have been no changes in ownership.
6. **Any changes in management, experience, and personnel relied on for certification in each semi-annual report before the REP begins serving customers and in the first semi-annual report after the REP serves customers. (Subst. R. 25.107(i)(5)(A)(vi)).** There have been no changes in ownership since TrailStone's Application to Amend its REP Certificate in PUCT Docket No. 51169, which was approved by the Commission on November 10, 2020.

7. **Documentation to demonstrate ongoing compliance with the financial requirements of subsection (f) of this section. (Subst. R. 25.107(i)(5)(A)(vii)).** The confidential filing in Exhibit A contains information and documentation demonstrating TrailStone's ongoing compliance with the financial requirements. Please note that on August 4, 2020, the Commission contacted TrailStone and requested that on or before March 5, 2021, TrailStone provide an updated letter of credit per P.U.C. Substantive Rule § 25.107(f)(4)(F). Accordingly, TrailStone has included its updated LOC in accordance with the Commission's rules as confidential filing in Exhibit B.



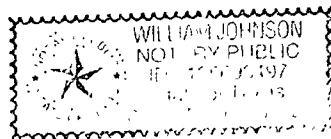
