MidAmerican Energy Services, LLC (“MES”) relies on a guarantor with an Investment Grade Credit Rating to satisfy the financial requirements of §25.107(f)(1) and provides commitments demonstrating compliance with §25.107(f)(4)(G)(ii). The commitment comes in the form of a notarized Secretary Certificate describing the parental guaranty provided by Berkshire Hathaway Energy Company (“BHEC”) to its subsidiary MES and a copy of the Market Participant Guarantee Agreement between ERCOT and BHEC for MES. To satisfy the documentation requirement of §25.107(f)(4)(A), credit ratings from Moody’s and Standard & Poor’s for BHEC are also included.

Please note this information is to be treated as confidential. This confidential information has been filed pursuant to PUCT Subst. Rule §22.71(d).

MES does not collect customer deposits and therefore the requirement in §25.107(f)(2) to reconcile and account for customer deposits is not applicable.
