COMMISSION STAFF'S REQUEST FOR EXTENSION

On December 10, 2020, Wood Acres Properties LLC (Wood Acres) filed an application to obtain a water and sewer certificate of convenience and necessity (CCN) in Montgomery County. The requested service area consists of approximately 16 acres and 29 customer connections.

On June 29, 2021, the administrative law judge (ALJ) filed Order No. 5, ordering the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation on the application and for Staff and Wood Acres (collectively, the Parties) to file joint proposed findings of fact and conclusions of law by July 23, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional financial information from Wood Acres to make a final recommendation and is working with Wood Acres to obtain that information. Wood Acres has relayed to Staff that providing additional financial information will take a few weeks. Thus, Staff requests an extension until August 20, 2021 to file a final recommendation and to file joint proposed findings of fact and conclusions of law.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to file a final recommendation and to file joint proposed findings of fact and conclusions of law until August 20, 2021.
