Additional Comments

Prior to the comprehensive compliance investigation, the water system had installed chloramine treatment equipment without obtaining approval prior to construction. The contracted engineer for the water system notified the water system of the construction approval requirements, directed the water system to take the equipment offline and prepared plans and specification for submission. At the time of the comprehensive compliance investigation, the investigator confirmed that the treatment equipment had been taken offline while the engineering plans and specifications are reviewed by the TCEQ Plan Review Team. The water system must ensure all significant changes are approved by the TCEQ Plan Review Team prior to construction.

30 TAC §290.39(j) Changes in existing systems or supplies. Public water systems shall notify the executive director prior to making any significant change or addition to the system's production, treatment, storage, pressure maintenance, or distribution facilities. Significant changes in existing systems or supplies shall not be instituted without the prior approval of the executive director.
