# COMPLAINANT AND COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

On December 14, 2020, Jeff Connors (Complainant) filed a formal complaint against the Gallery Apartments (Apartment), Roscoe Property Management (RPM), and Conservice (together, Respondents) regarding improper billing practices.<sup>1</sup> This complaint was filed under 16 Texas Administrative Code (TAC) § 22.242.

On July 25, 2022, the administrative law judge held a pre-hearing conference, in which she ordered the Complainant and Staff (Staff) of the Public Utility Commission (Commission) to file a procedural schedule for continued processing of this docket. Only the Complainant and Staff appeared at the pre-hearing conference.
