
**JOINT PROPOSED REVISED PROCEDURAL SCHEDULE**

CSWR-Texas Utility Operating Company, LLC (“CSWR Texas”) submits this request to amend the procedural schedule to add a deadline for the parties to submit a joint proposed order approving the transaction to proceed. The current procedural schedule was adopted on May 19, 2021 in Order No. 4 and corrected on May 21, 2021 in Order No. 5. After consultation with Staff of the Public Utility Commission of Texas (“Staff”), Counsel for CSWR Texas is authorized to represent that Staff is in agreement with the below proposed revised procedural schedule.


