COMES NOW, Aqua Water Supply Corporation ("Aqua WSC") and Waters of Vista Ranch Water Supply Corporation ("WOVR WSC") (collectively, "Applicants") in the above-referenced matter, and hereby file this January 2022 Status Report in response to Order No. 14, Ordering Paragraph 6, directing the Applicants to file monthly updates regarding the status of closing and to submit documents evidencing that the transaction was consummated.<sup>1</sup>

Applicants have been diligently working to close the transaction following the Honorable Administrative Law Judge's November 18, 2021, Order No. 14, Approving Sale and Transfer to Proceed. Applicants have been in constant coordination regarding closing, and anticipate closing well in advance of the 180-day deadline established by Ordering Paragraph 3, of Order No. 7, and will immediately notify the Public Utility Commission of Texas upon closing.<sup>2</sup>
