COMES NOW, Aqua Water Supply Corporation (“Aqua WSC”) and Waters of Vista Ranch Water Supply Corporation (“WOVR WSC”) (collectively, “Applicants”) in the above-referenced matter, and hereby file this August 2022 Status Report in response to Order No. 16, granting a second extension of time to complete the transaction and directing the Applicants to file a monthly update regarding the status of closing and to submit documents evidencing that the transaction was consummated.<sup>1</sup>

Applicants are pleased to report that they have resolved the outstanding title issues associated with the property underlying WOVR WSC’s groundwater well site. Applicants have obtained approval from the Fayette County Commissioners Court for the division of the property underlying WOVR WSC’s groundwater well site, and are prepared to move forward with closing. Applicants are working diligently to schedule a closing date within the next three weeks, and will immediately notify the Public Utility Commission of Texas upon closing.
