## JOINT MOTION TO ADMIT EVIDENCE

Community Water Company (Community Water) and the Staff of the Public Utility Commission of Texas (Commission) (collectively, Parties) file this Joint Motion to Admit Evidence (Motion). In support of the Motion, the Parties respectfully show the following:

#### I. BACKGROUND

On December 22, 2020, Community Water, operating under certificate of convenience and necessity (CCN) No. 10534, filed an application to implement a pass-through rate change under 16 Texas Administrative Code (TAC) § 24.25(b)(2)(F) for an increase in the purchased water fee billed by the City of Tyler. On March 1, 2021, the Parties filed a Joint Notice of Approval, pursuant to Order No. 2.<sup>1</sup> On March 8, 2021, the administrative law judge (ALJ) filed Order No. 3,<sup>2</sup> requiring the Parties to file a Joint Motion to Admit Evidence by March 12, 2021. Accordingly, this motion is timely filed.

#### II. MOTION TO ADMIT EVIDENCE

The Parties request that the following evidence be admitted into the record for the purpose of supporting the notice of approval in this proceeding:

- 1. Application of Community Water Company for a Pass-Through Rate Change, filed on December 22, 2020 (Interchange Item No. 2); and
- 2. Commission Staff's Recommendation on the Application and Notice, filed on January 19, 2021 (Interchange Item No. 4).
