## COMMISSION STAFF'S REQUEST FOR EXTENSION

On December 28, 2020, the City of Anna (Anna) filed an application to amend its sewer certificate of convenience and necessity (CCN) number 20898 in Collin County, Texas. The requested service area consists of 105 acres with no current customers. On January 7, 2021, March 24, 2021, April 8, 2021, June 22, 2021, and September 10, 2021, Anna filed supplemental information.

On September 14, 2021, the administrative law judge (ALJ) filed Order No. 6, requiring Staff (Staff) of the Public Utility Commission (Commission) to file a request for a hearing or recommendation on final disposition by October 25, 2021. Therefore, this pleading is timely filed.

## I. REQUEST FOR EXTENSION

In accordance with 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is waiting for Anna to provide the Texas Commission on Environmental Quality approval letter for the Texas Pollutant Discharge Elimination System permit that will provide service for the requested area. Accordingly, Staff requests that its deadline to request a hearing or file a recommendation on final disposition be extended to October 25, 2021.

### II. CONCLUSION

Staff respectfully requests the issuance of an order consistent with the foregoing recommendation.
