This purpose of this submittal is to provide an update regarding the Texas Pollutant Discharge Elimination System (TPDES) Permit. TCEQ declared the application administratively complete on December 07, 2021, and the first public posting has closed. The permit is near the end of the notice of application and preliminary decision phase of review. Once the TCEQ completes the first draft, the permit will be advertised for public comment. Senate Bill 709 (84th Legislative Session, 2015) amended the Texas Water Code by adding new Section 5.5553, which requires the Texas Commission on Environmental Quality (TCEQ) to provide written notice to you at least thirty (30) days prior to the TCEQ's issuance of draft permits for applications that are located in your district.

City of Anna, P.O. Box 776, Anna, Texas 75409, has applied to the TCEQ for proposed Texas Pollutant Discharge Elimination System No. WQ0016043001 (EPA I.D. No. TX0141721) to authorize the discharge of treated wastewater at a volume not to exceed an annual average flow of 16,000,000 gallons per day. The domestic wastewater treatment facility will be located approximately 1.56 miles west of the intersection of the Collin County Outer Loop and U.S. Highway 75, in Collin County, Texas 75409. The discharge route will be from the plant site to an unnamed tributary, thence to East Fork Trinity River above Lavon Lake, thence to Lavon Lake in Segment No. 0821 of the Trinity River Basin. TCEQ received this application on September 17, 2021. The permit application is available for viewing and copying at Anna City Hall, 111 North Powell Parkway, Anna, Texas. This link to an electronic map of the site or facility's general location is provided as a public courtesy and not part of the application or notice. TCEQ is preparing the initial draft permit. At the time the draft permit is issued, the applicant will be required to publish notice in a newspaper of general circulation, and the TCEQ will provide a copy of the notice of draft permit to persons who have requested to be on a mailing list.
