**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On December 28, 2020, the City of Anna (Anna) filed an application to amend its sewer certificate of convenience and necessity number 20898 in Collin County, Texas. The requested service area consists of 105 acres with no current customers.

On October 19, 2023, the administrative law judge filed Order No. 12, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates, and tariffs (if applicable) to Anna for review and consent by November 17, 2023. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

In accordance with 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to prepare the final map for Anna. Accordingly, Staff requests that its deadline to provide final maps, certificates, and tariffs (if applicable) to Anna for review and consent be extended to December 8, 2023.

**II. CONCLUSION**

For the reasons stated above, Staff respectfully requests that the deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to Anna for review and consent be extended to December 8, 2023.
