The City of Anna has filed an application with the Public Utility Commission of Texas to amend its Certificate of Convenience and Necessity (CCN) No. 20898 for the provision of retail sewer utility service in Collin County, Texas.

The requested area includes <u>0</u> current customers, is located approximately <u>4</u> mile(s) <u>southeast</u> of downtown <u>Anna</u>, Texas, and is generally bounded on the north by <u>a line approximately 700' north</u> <u>of County Road 286</u>; on the east by <u>County Road 277</u>; on the south by <u>County Road 286</u>; and on the west by <u>East Fork Trinity River</u>.

Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
