ORDER NO. 21 FINDING NOTICE SUFFICIENT AND ENTERING ADDITIONAL EVIDENCE

This Order addresses the City of Anna's May 8, 2024 landowner notice and affidavit, along with Commission Staff's January 19, 2024 joint motion to admit evidence and Commission Staff's May 9, 2024 response to Order No. 20, recommendation on sufficiency of notice, and motion to admit evidence.

On May 8, 2024 the City of Anna filed the affidavit of Mr. Todd Strouse, representative for the City, attesting that notice of this application, with a map, had been sent via first-class mail on May 8, 2024 to Mr. John Rattan the only landowner owning a tract of land over 25 acres wholly or partly inside the CCN requested area in this application.

Commission Staff reviewed the City's supplemental proof of notice filed on May 8, 2024 and recommended that it be found sufficient.

The administrative law judge (ALJ) finds the City's supplemental notice sufficient.
