I. BACKGROUND

On January 5, 2021, Integra filed its application for a sewer certificate of convenience and necessity (CCN) in Bastrop County (Application) with the Public Utility Commission of Texas (Commission) in this docket. A notice of approval was filed on October 8, 2021, which orders Integra to (1) comply with the recording requirements in Texas Water Code (TWC) §§ 13.257(r) and (s) for the areas in Bastrop County affected by the application, and (2) file proof of such recording.¹ Integra recorded the map, CCN certificate and boundary description with Bastrop County and hereby files this Evidence of Recording.

II. EVIDENCE OF RECORDING

Integra hereby submits the evidence of recording attached hereto and incorporated herein for all purposes as **Attachment A**, which contains the following documents recorded in the Official Public Records of Bastrop County, Texas on January 11, 2021: (a) a certified copy of CCN number 21126; (b) a certified copy of the map for the areas affected (Area Affected) by this application; and (c) a boundary description of the Area Affected.²

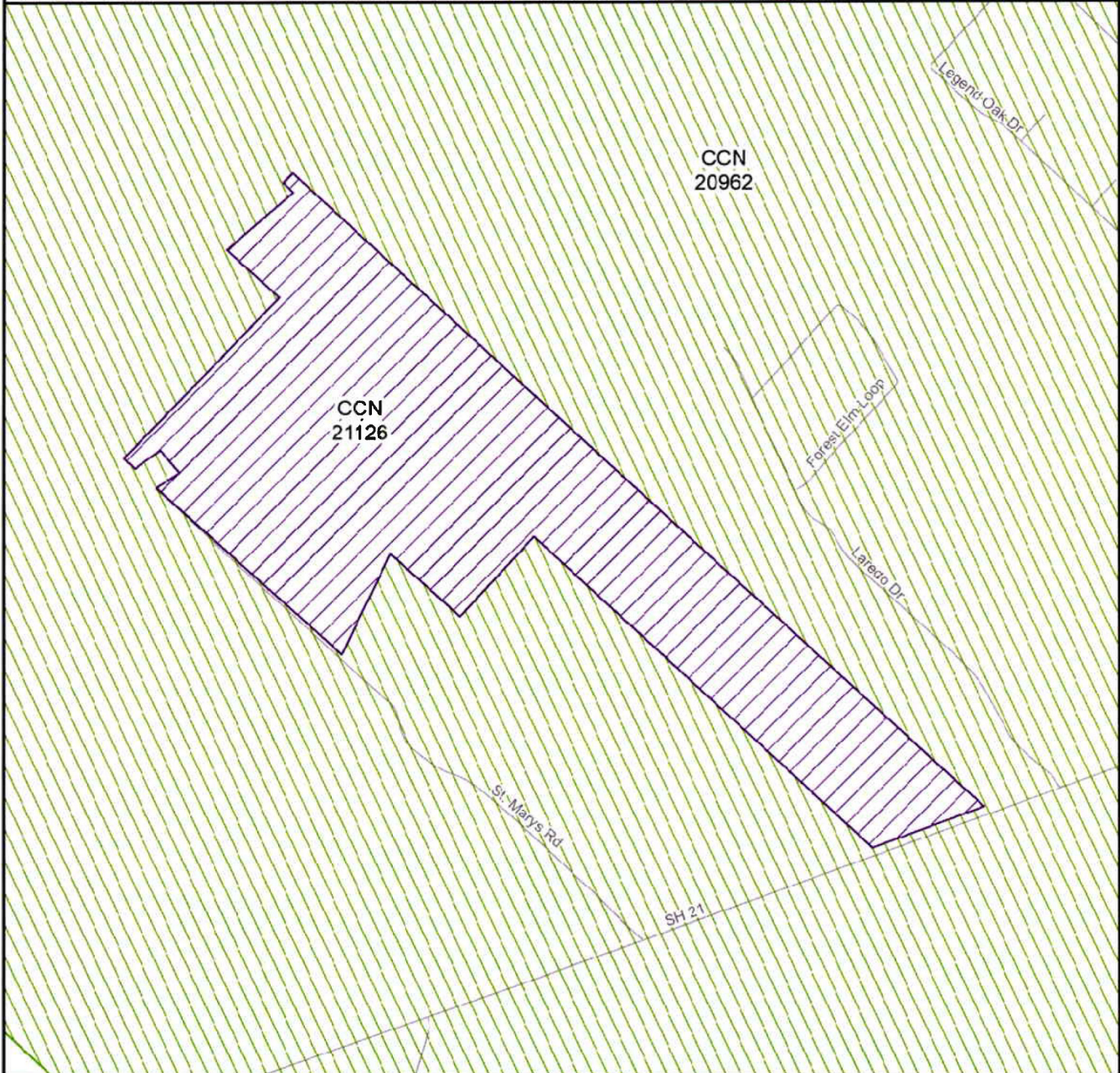

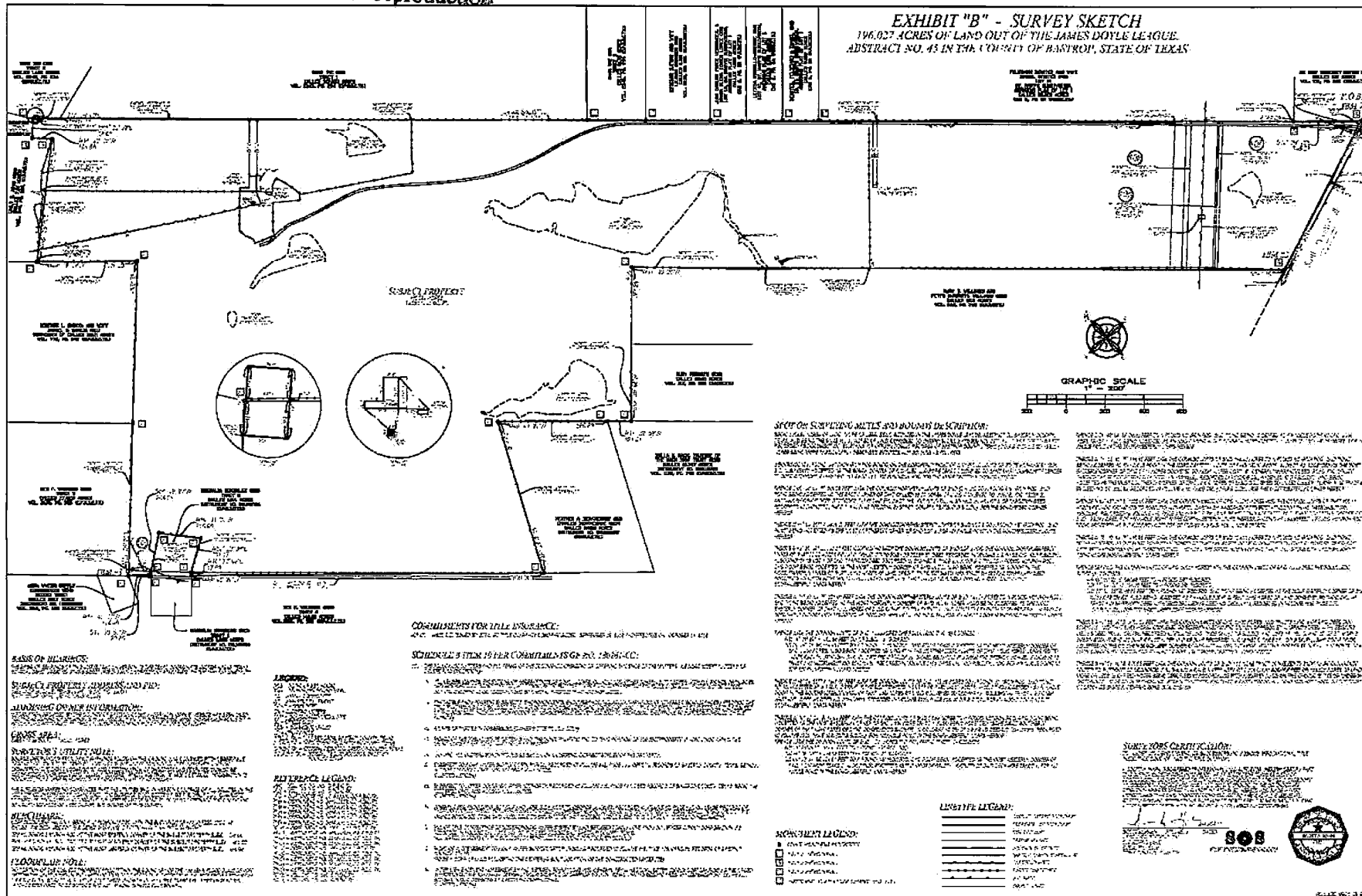
