- **Staff 1-4** Please describe any water meters located within the Tract and provide the date on which each meter was last active.
- Staff 1-5 Please describe any water lines located within the Tract, including the diameter of the line, the length of the portion of the line that is located within the Tract, and the date the line was put in service.
- Staff 1-6 Please describe any water lines that are located in close proximity to, but not within, the Tract. For each line described, please include the diameter, the length of the portion of the line that is in close proximity to the Tract, and the date the line was placed into service.
- Staff 1-7 Please describe any water facilities located within the Tract, including the total capacity of the facility, the current unused capacity of the facility, and the date the facility was placed into service.
