#### COMMISSION STAFF'S RECOMMENDATION ON FINAL DISPOSITION

On January 8, 2021, Trendmaker Homes, Inc. (Trendmaker) filed a petition to amend MSEC Enterprises, Inc.'s (MSEC) water certificate of convenience and necessity (CCN) No. 12887 in Montgomery County, Texas, under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). On February 22, 2021, the administrative law judge granted MSEC's February 18, 2021 motion to intervene.

Order No. 2, filed on February 5, 2021, established a deadline of March 5, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to file a recommendation on final disposition. Therefore, this pleading is timely filed.

#### I. RECOMMENDATION ON FINAL DISPOSITION

As detailed in the attached memorandum of Patricia Garcia of the Commission's Infrastructure Division, Staff has reviewed the petition and recommends that it be approved.

#### II. MOTION TO WITHDRAW REQUESTS FOR INFORMATION

On March 3, 2021, Staff served requests for information on both Trendmaker and MSEC. Staff moves to withdraw those requests.

#### III. CONCLUSION

For the reasons detailed above, Staff respectfully recommends that the application be approved.

by Expedited Release

On January 8, 2021, Trendmaker Homes, Inc. (Trendmaker Homes) filed a petition for streamlined expedited release from MSEC Enterprises, Inc.'s (MSEC) water certificate of convenience and necessity (CCN) No. 12887 in Montgomery County, under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). Trendmaker Homes asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Montgomery County, which is a qualifying county.

Trendmaker Homes submitted adequate maps delineating the requested area for expedited release with enough detail to confirm the accurate positioning of its digital data under 16 TAC § 24.245(k). The map and digital data are sufficient for determining the location of the requested release area within MSEC's certificated area. Gary Horton, Infrastructure Division, was able to confirm the acreage of the subject property and determined that the requested area is located within MSEC's water CCN. Furthermore, Trendmaker Homes provided a warranty deed confirming ownership of the property within MSEC's certificated area. In addition, Trendmaker Homes submitted a sworn affidavit attesting that the property was not receiving water service from the CCN holder. The tract of land is approximately 125.45 acres. The requested area to be released from MSEC (CCN No. 12287) is approximately 125.08 acres.

MSEC's request to intervene was granted intervention by the administrative law judge on February 22, 2021.

In accordance with TWC § 13.2541 and 16 TAC § 24.245(h), Trendmaker Homes has met the Commission's requirements to allow for the release of the requested area from MSEC's CCN No. 12287. Therefore, I recommend approval of the petition. Enclosed is a final map and certificate for Commission approval.

Additionally, I recommend that the attached final map and certificate be provided to the CCN holder.


