

1. My name is Charles M. DeWitt. I am employed by Pedernales Electric Cooperative, Inc. ("PEC") as Transmission Development Director. I am responsible for overseeing the notice provided for the proposed upgrade of T323 Marshall Ford to Paleface transmission line in Travis County, Texas (the "Proposed Project").
