

Submetered hot water. The individually submetered hot water used in the tenant=s dwelling unit is divided by all submetered hot water used in all dwelling units.

Submetered cold water is used to allocate charges for hot water provided through a central system. The individually submetered cold water used in the tenantes dwelling unit is divided by all submetered cold water used in all dwelling units.


