COMMISSION STAFF' S REQUEST FOR EXTENSION

On January 20, 2021, Sanctuary Texas, LLC (Sanctuary) filed a petition for streamlined expedited release of approximately 69.113 acres of land within the boundaries of Aqua Texas, Inc.'s (Aqua Texas) water certificate of convenience and necessity (CCN) number 13201 in Denton County, Texas under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h).

On April 19, 2021, the administrative law judge filed Order No. 3, establishing a deadline for Staff of the Public Utility Commission of Texas (Staff) to file its recommendation on final disposition by May 10, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to finalize its recommendation on final disposition. Accordingly, Staff requests that its deadline to file its recommendation on final disposition be extended to May 17, 2021.

II. CONCLUSION

Staff respectfully requests the issuance of an order granting Staff's request and extending the deadline for Staff's recommendation on final disposition to May 17, 2021.
