### **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On January 20, 2021, Sanctuary Texas, LLC (Sanctuary) filed a petition for streamlined expedited release of approximately 69.113 acres of land within the boundaries of Aqua Texas, Inc.'s (Aqua Texas) water certificate of convenience and necessity (CCN) number 13201 in Denton County, Texas under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h).

On June 9, 2021, the administrative law judge filed Order No. 5, establishing a deadline for Staff of the Public Utility Commission of Texas (Staff) to file (1) a proposed map that is consistent with Sanctuary Texas, LLC's mapping of the area for which it seeks streamlined expedited release, (2) proposed maps that are consistent with Staff's recommendation, and alternative recommendation, and (3) a proposed certificate by June 16, 2021. Therefore, this pleading is timely filed.

#### **I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to prepare the requested maps and certificate. Accordingly, Staff requests that its deadline to file the requested maps and certificate be extended to June 24, 2021.

#### **II. CONCLUSION**

Staff respectfully requests the issuance of an order granting Staff's request and extending the deadline for Staff to file the requested maps and certificate to June 24, 2021.
