

COMMISSION STAFF'S RESPONSE TO ORDER NOS. 5 AND 6

On January 20, 2021, Sanctuary Texas, LLC (Sanctuary) filed a petition for streamlined expedited release of approximately 69.113 acres of land within the boundaries of Aqua Texas, Inc.'s (Aqua Texas) water certificate of convenience and necessity (CCN) number 13201 in Denton County, Texas under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h).

On June 9, 2021, the administrative law judge (ALJ) filed Order No. 5, establishing a deadline for Staff of the Public Utility Commission of Texas (Staff) to file (1) a proposed map that is consistent with Sanctuary Texas, LLC's mapping of the area for which it seeks streamlined expedited release; (2) proposed maps that are consistent with Staff's recommendation and alternative recommendation; and (3) a proposed certificate by June 16, 2021. On June 16, 2021 the ALJ filed Order No. 6, granting Staff's request for an extension to June 24, 2021. Therefore, this pleading is timely filed.

I. REQUESTED MAPS AND CERTIFICATE

Staff now files the attached maps in accordance with Order Nos. 5 and 6. At the bottom, right-hand corner of each map is a description for reference. The two maps with the descriptions that read "Petitioner Proposal" are consistent with Sanctuary Texas, LLC's mapping of the area that was deemed sufficient in Order No. 3 filed on April 19, 2021. The next two maps with the descriptions that read "Staff Proposal 1" are consistent with Staff's recommendation on final disposition filed on May 17, 2021. Finally, two maps with the descriptions that read "Staff Proposal 2" are consistent with Staff's alternative recommendation on final disposition. The certificate for CCN number 13201 is likewise attached.




