**COMMISSION STAFF'S REQUEST FOR CLARIFICATION REGARDING FINAL
MAP**

On January 20, 2021, Sanctuary Texas, LLC (Sanctuary) filed a petition for streamlined expedited release of approximately 69.113 acres of land within the boundaries of Aqua Texas, Inc.'s (Aqua Texas) water certificate of convenience and necessity (CCN) number 13201 in Denton County, Texas under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). On June 24, 2021, Staff (Staff) of the Public Utility Commission (Commission) filed its response to Orders No. 5 and 6, which included several proposed maps. On June 24, 2021, the administrative law judge (ALJ) filed a Proposed Order.

I. REQUEST FOR CLARIFICATION REGARDING FINAL MAP

The maps filed by Staff on June 24, 2021 were all marked as "proposals" and are not final maps for the purposes of the Commission's official CCN mapping records. Staff seeks clarification that the map attached to the proposed order filed on June 24, 2021 shows the CCN boundaries the ALJ proposes to be used on the final map. Once clarification is received, Staff will prepare a final map, which requires editing the map title and adding the state seal and Public Utility Commission of Texas, and file it in the docket.

II. CONCLUSION

Staff respectfully requests the issuance of an order in accordance with the foregoing recommendation.
