**AGREED STATUS REPORT**

On February 3, 2021, Nueces Bay Tracts, LLC (Nueces Bay) filed a formal complaint against Rincon Water Supply Corporation (Rincon) regarding the extension of water service to a proposed subdivision. This complaint was filed under 16 Texas Administrative Code (TAC) § 22.242. On May 26, 2021, Nueces Bay amended its complaint, stating that Rincon had effectively refused service and violated multiple tariff provisions. On August 17, 2021, this matter was referred to the State Office of Administrative Hearings (SOAH).

On January 4, 2022, the SOAH administrative law judge (ALJ) filed SOAH Order No. 4, requiring the parties to file a status report by January 28, 2022 and every 30 days thereafter. Therefore, this pleading is timely filed.

**I. STATUS REPORT**

Staff is authorized to represent that the parties are engaged in discussions regarding how to proceed with this docket. For this reason, Staff requests that the procedural schedule remain abated. In accordance with SOAH Order No. 4, the parties will file their next status report, including a request for the assignment of a mediator or a request that the abatement be lifted, on or before April 27, 2022.

**II. CONCLUSION**

So that the parties may continue settlement negotiations, Staff respectfully requests that the procedural schedule remain abated.
