JOINT MOTION TO WITHDRAW

COME NOW, Complainant Nueces Bay Tracts, LLC (“NBT”) and Rincon Water Supply Corporation (“Rincon”) and file this Joint Motion to Withdraw.

I. MOTION TO WITHDRAW

On February 3, 2021, NBT filed a formal complaint against Rincon with the Public Utility Commission of Texas (“Commission”). After the Complaint was referred to the State Office of Administrative Hearings (“SOAH”) on August 17, 2021, the case was further referred to SOAH ADR where a resolution was reached on July 15, 2022. Thereafter, SOAH issued Order No. 7 remanding this case to the Commission for dismissal. On October 18, 2022, the Commission Administrative Law Judge (“ALJ”) issued Order No. 3 requiring a procedural schedule or joint motion to withdraw by November 1, 2022. Therefore, this pleading is timely filed.

In light of the mediated settlement, NBT and Rincon request that the matter be withdrawn.

II. PRAYER

Based on the foregoing, NBT and Rincon respectfully pray that the Commission ALJ grant the Joint Motion to Withdraw and dismiss this uncontested case.
