**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On February 3, 2021, Undine Texas, LLC (Undine) filed an application for approval of pass-through rate increases in accordance with ordering paragraph number 3 of the Notice of Approval filed on February 3, 2020 in Docket No. 49570.<sup>1</sup>

On March 4, 2021, the administrative law judge (ALJ) filed a notice setting a deadline of March 11, 2021 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the application and notice. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is still analyzing Undine's application, which includes proposed pass-through rate changes involving eight separate pass-through calculations, and requests this extension so that it may complete its review. Therefore, Staff requests that the deadline to file a recommendation on the application and notice be extended to March 22, 2021.

**II. CONCLUSION**

For the reasons specified above, Staff respectfully requests that the ALJ grant an extension of time for Staff to file a recommendation on the application and notice.
