TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

WUSF 5 Rock Creek East, LP ("WUSF 5") and Walton Texas, LP ("Walton Texas") (collectively referred to as the "Petitioners") file this supplement to the petition for expedited release from water certificate of convenience and necessity ("CCN") No. 10081, held by Weston Water Supply Corporation ("Weston WSC"), filed by Petitioners on February 5, 2021 with the Public Utility Commission of Texas (the "PUC") for expedited release. This supplement is being filed in order to cure the mapping deficiencies noted in the March 5th Memorandum prepared by the Staff of the Public Utility Commission. The property owned by Petitioners is now appropriately reflected in the Revised General Location Map, Revised Detailed Map and Digital Mapping Data provided to the PUC.
