**COMMISSION STAFF'S RECOMMENDATION ON FINAL DISPOSITION**

On February 11, 2021, the City of Georgetown (Georgetown) and Jarrell-Schwertner Water Supply Corporation (JSWSC) (collectively, the Petitioners) filed a petition for approval of a service area contract under Texas Water Code (TWC) § 13.248 and to amend the Georgetown's water certificate of convenience and necessity (CCN) number 12369 and JSWSC's water CCN number 10002 in Williamson County, Texas. The Petitioners' TWC § 13.248 service area contract is being reviewed in accordance with 16 Texas Administrative Code (TAC) § 24.253.

On September 20, 2021, the administrative law judge (ALJ) filed Order No. 6 requiring Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and proposed notice and propose a procedural schedule by November 19, 2021. Therefore, this pleading is timely filed.

**I. FINAL RECOMMENDATION**

After review, and as supported by the attached memorandum of Pai Liu of the Infrastructure Division, Staff recommends approval of the application. Staff's review indicates that the Applicants meet the requirements of Chapter 13 of the Texas Water Code and Title 16, Chapter 24 of the Texas Administrative Code. The Applicants will not transfer assets or facilities under the terms of the agreement, and customers in the area subject to the transfer will continue to receive service from JSWSC.

Staff further recommends that the Applicants file certified copies of the attached certificate of convenience and necessity (CCN) map, along with a written description of the CCN service areas in the Williamson County Clerk's Office, as required by TWC § 13.257(r) and (s). Staff has attached copies of the final map and certificates consented to by the Applicants to this final recommendation.

On or before February 18, 2022, the parties will file joint proposed findings of fact and conclusions of law in accordance with Order No. 7.

## **II. CONCLUSION**

For the reasons detailed above, Staff respectfully recommends that the application be approved.

On February 11, 2021, the City of Georgetown (Georgetown) and Jarrell-Schwertner Water Supply Corporation (JSWSC) (collectively, Petitioners) filed a petition for approval of a service area contract under Texas Water Code (TWC) § 13.248 and to amend Georgetown's water certificate of convenience and necessity (CCN) No. 12369 and JSWSC's water CCN No. 10002 in Williamson County, Texas. The Petitioners' TWC § 13.248 service area contract is being reviewed in accordance with 16 Texas Administrative Code (TAC) § 24.253.

The Petitioners filed an agreement requesting that JSWSC be permitted to continue to provide retail water utility service to 14 property owners that are located within Georgetown's water CCN No. 12369.

The requested area includes approximately 4,224 acres of transferred area from City of Georgetown (CCN No. 12369) to Jarrell-Schwertner WSC (CCN No. 10002).

The result of the petition will be the subtraction of approximately 4,224 acres from CCN No. 12369. The result of the petition will be the addition of approximately 4,224 acres to CCN No. 10002.

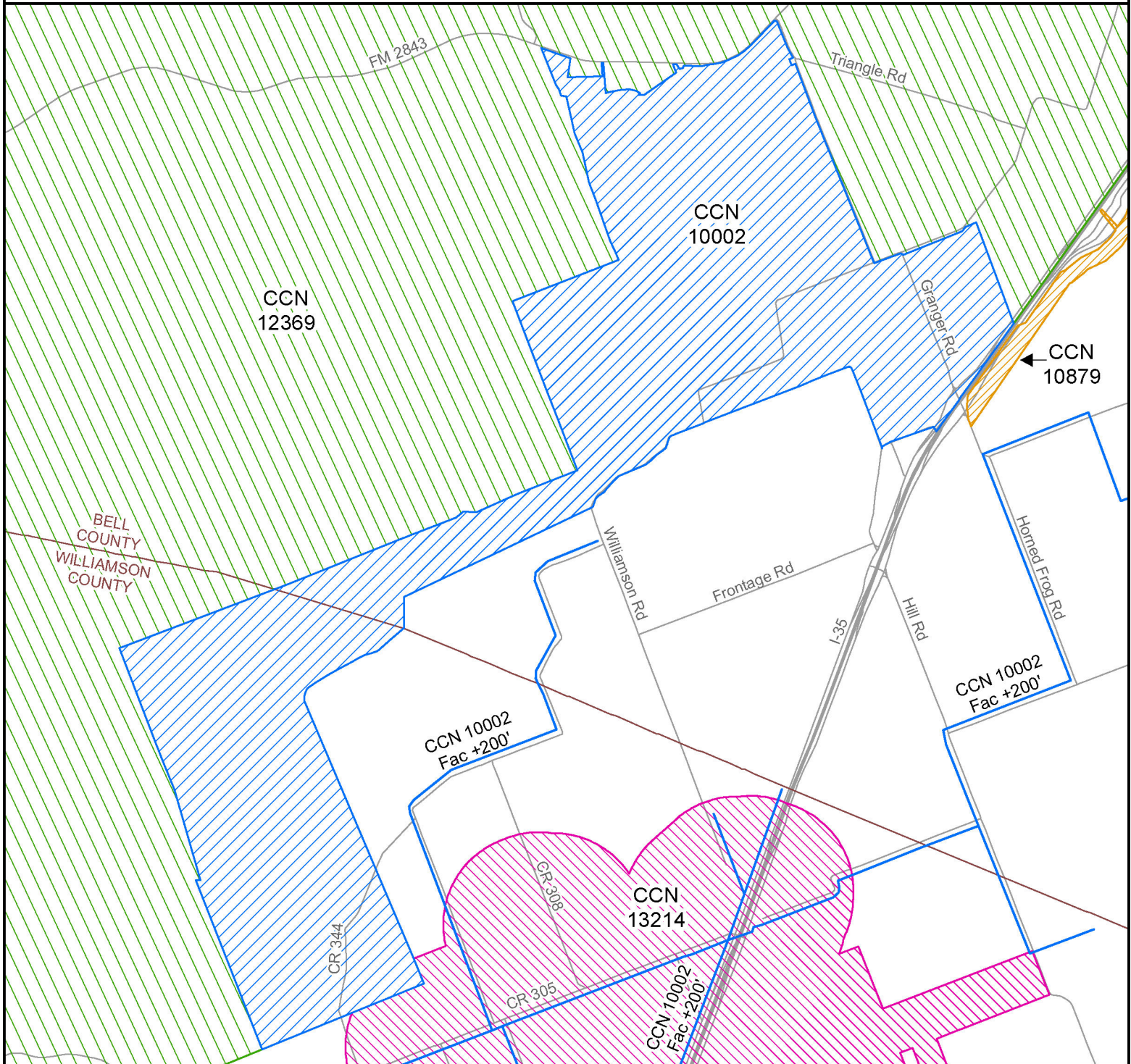
The customers are currently provided service by Jarrell-Schwertner WSC and will continue to receive service from Jarrell-Schwertner WSC. No assets or facilities are being transferred under the terms of the agreement.

The Petitioners submitted documentation to satisfy the notice requirements under 16 TAC § 24.253(c).

The petition meets all applicable statutory requirements of TWC Chapter 13 and 16 TAC Chapter 24 rules and regulations. Therefore, I recommend approval of the petition.

The Petitioners consented to the attached map and certificates on January 13, 2022 and January 14, 2022.

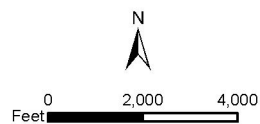
