 - 2. Attachment B includes the same 3 parcels highlighted in yellow showing the existing 4" water line, 3" sewer force main and sewer lift station. The customers own the gravity sewer lines from their buildings up to the lift station and the water service lines from the

meters to their buildings. UIC 13, LLC owns the water main, the sewer force main and the lift station.




