COMMISSION STAFF'S REQUEST FOR EXTENSION

On February 18, 2021, UIC 13, LLC (UIC) filed an application to amend its water certificate of convenience and necessity (CCN) No. 13242 and sewer CCN No. 21091 in Harris County, Texas under Texas Water Code (TWC) §§ 13.242 to 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237. The requested area includes nine current customers and is comprised of approximately 67 acres of uncertificated area. The result of the application will be the addition of approximately 67 acres to CCN Nos. 13242 and 21091.

On September 9, 2021, Order No. 7 was issued, requiring UIC and the Staff of the Public Utility Commission of Texas (Staff) (collectively, the Parties) to file a revised joint motion to admit evidence and proposed order for continued processing of this matter by September 24, 2021.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has distributed a copy of the revised joint filings and the parties require additional time to finalize their review and exchange the requisite signatures. Therefore, Staff respectfully requests the parties' deadline to file a revised joint motion to admit evidence and proposed order for continued processing of this matter be extended to October 1, 2021.

II. CONCLUSION

Staff respectfully requests that the parties' deadline to file a revised joint motion to admit evidence and proposed order be extended to October 1, 2021.
