#### COMMISSION STAFF'S RECOMMENDATION ON FINAL DISPOSITION

On February 26, 2021, Bernadine C. King, Trustee of the Hinsvark Family Trust (Ms. King) filed a petition for streamlined expedited release of approximately 217.9 acre tract of land that lies within Aqua Texas, Inc.'s (Aqua Texas) water certificate of convenience and necessity (CCN) number 21116 in Bastrop County, under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). Ms. King asserts that the tract of land is at least 25 acres, is not receiving water service, and is located in Bastrop County, which is a qualifying county.

On May 19, 2021, the administrative law judge (ALJ) filed Order No. 3 setting a deadline of June 21, 2021, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on final disposition. Therefore, this pleading timely filed.

#### T. RECOMMENDATION ON FINAL DISPOSITION

As detailed in the attached memorandum from Patricia Garcia in the Commission's Infrastructure Division, Staff has reviewed the petition for streamlined expedited release, as supplemented on April 23, 2021, and recommends that it be approved. The maps and digital data filed by Ms. King provide adequate information demonstrating that the petition satisfies the requirements of TWC § 13.2541(b) and 16 TAC § 24.245(h). Specifically, the maps and digital data provided by Ms. King enable Staff to determine that the requested area: (1) is at least 25 acres; (2) is not receiving wastewater service; (3) is located within Aqua Texas' certified area; and (4) is located within Bastrop County, which is a qualifying county.

In Aqua Texas' response to the petition, it argues that the property is receiving wastewater service because Aqua Texas has: (1) wastewater facilities are present proximate to and made available for a subject tract within Aqua Texas' CCN service area; and (2) Aqua Texas has performed various acts and supplied funds in furtherance of service to CCN No. 21116's service area, which includes the requested area. Staff maintains that these steps are not adequate to show that the requested area is receiving wastewater service from Aqua Texas because they do not demonstrate that Aqua Texas has committed or dedicated facilities or lines specifically for providing wastewater service to the property or performed acts or supplied anything to the property.<sup>1</sup>

In addition, the deed provided by the Petitioner confirms that the Petitioner owns the property. Consequently, the Petitioner has shown that it meets the requirements for streamlined expedited release.

#### II. CONCLUSION

For the reasons detailed above, Staff respectfully requests that an interim order be issued granting Ms. King's petition for streamline expedited release.

Necessity in Bastrop County by Expedited Release

On February 26, 2021, Bernadine C. King, Trustee of the Hinsvark Family Trust (Hinsvark Family Trust) filed an application for streamlined expedited release from Aqua Texas, Inc.'s (Aqua Texas) sewer certificate of convenience and necessity (CCN) No. 21116 in Bastrop County, under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). The Hinsvark Family Trust asserts that the land is at least 25 contiguous acres, is not receiving sewer service, and is located in Bastrop County, which is a qualifying county.

The Hinsvark Family Trust submitted adequate maps delineating the tract of land area for expedited release with enough detail to confirm the accurate positioning of its digital data under 16 TAC § 24.245(k). Tracy Montes, Infrastructure Division, determined the map and digital data are sufficient for determining the location of the area considered for expedited release is within Aqua Texas' sewer CCN No. 21116. The total property is approximately 269 acres. The requested area to be released from Aqua Texas' CCN No. 21116 is approximately 217.9 acres.

Aqua Texas requested to intervene in the docket and the request was granted. Aqua Texas stated facilities are in place to serve growth in the vicinity of the property and that it has made other planning efforts to ensure its sewer system meets the needs of its service area.

In accordance with TWC § 13.2541 and 16 TAC § 24.245(h), the Hinsvark Family Trust has met the Commission's requirements to allow for the release of the requested area from Aqua Texas' CCN No. 21116. Therefore, I recommend approval of the petition. Enclosed is a final map and certificate for Commission approval.

Additionally, I recommend that a final map and certificate be provided to the CCN holder.




