**PETITIONER'S MOTION TO STRIKE AQUA TEXAS' SUPPLEMENTAL RESPONSE**

Now comes the Hinsvark Family Trust, the Petitioner, and files this Motion to Strike Aqua Texas' Supplemental Response. This motion is timely.

**I.**

Order No. 3 adopted the procedural schedule in this docket and the schedule set a deadline for the CCN holder to respond to the petition and a deadline for the Petitioner to reply to CCN holder's response. The CCN holder filed its response and the Petitioner timely filed a reply. But then, the CCN holder filed a supplemental response without conferring with the Petitioner, without asking for permission to file a supplemental response, without asking for a modification of the procedural schedule, and without showing good cause why the supplemental response is necessary or should be allowed.

**II.**

If the commission chooses not to strike the supplemental response, the allegations in the supplemental response should be disregarded because the affiant supporting the supplemental response is not credible. The affiant did not know where the Hinsvark Tract was located and his

prior allegations regarding service to the tract were wrong, misleading, and irrelevant to the Hinsvark tract.

III.

The Hinsvark Family Trust prays that Aqua Texas' supplemental response be stricken in its entirety, or alternatively disregarded.


