**FIRST ADDENDUM TO PETITION

**I. Introduction**

This First Addendum to Petition (First Addendum) transmits electronic mapping information related to the February 26, 2021 petition of Bernadine C. King, Trustee of the Hinsvark Family Trust ("Hinsvark") to amend Aqua Texas, Inc. sewer utility certificate of convenience and necessity (CCN) in Bastrop County. Order No. 2 adopts the Commission Staff's finding that the mapping documentation filed with the petition is deficient and required the petitioner to cure the deficiencies by April 29, 2021. This filing is timely.

**II. Electronic Mapping**


Attached with this First Addendum are the PUC required mapping information in PDF and shapefile format. The information includes:

- Digital mapping data for the subject property to be released, provided as a single polygon record, in a shapefile (SHP) format, georeferenced in either NAD83 Texas Statewide Mapping System (Meters) or NAD83 Texas State Plane Coordinate System.

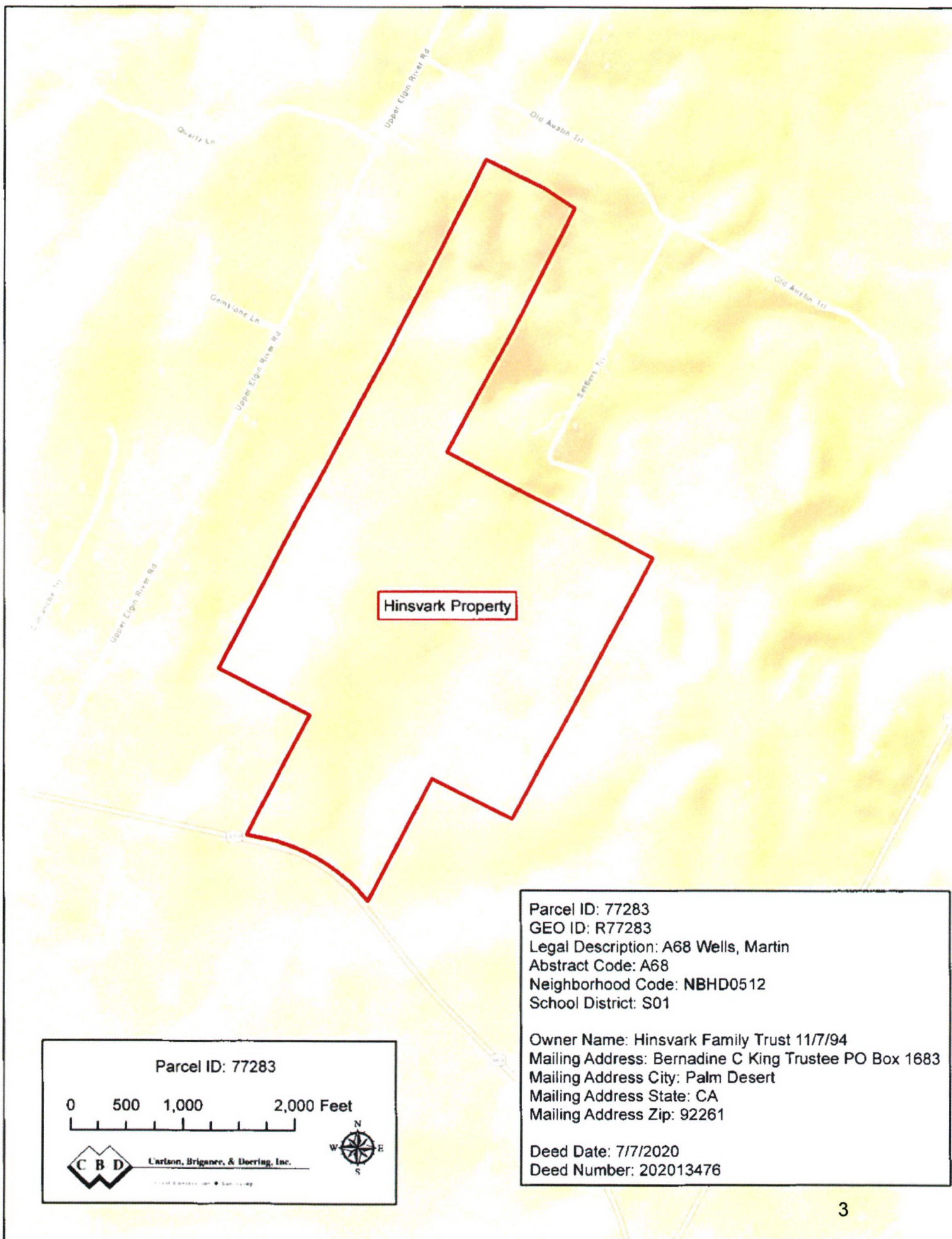
