Deadline for CSWR Texas to respond to comments and Commission Staff's recommendation on final disposition or request for hearing; if no disputed issues exist, deadline for parties to file a joint motion to admit evidence and proposed notice of approval	May 17, 2021
Administrative review completed 90 days from the date the Commission received notice of temporary rate increase, under Texas Administrative Code § 24.363	May 27, 2021
