Dear Ms. Wilkins:

Management Support is applying for approval to change the properties listed below from submetered to allocated billing. All of these properties were sub-metered prior to Management Support purchasing them. These properties are experiencing various problems that prevent us from providing accurate bills to our residents. The problems include counter failures, non-replaceable battery failures, breakdown of reading systems that are no longer being manufactured or the manufacturer is no longer in business. In one particular case the reading system is Proprietary, and the manufacturer will not release the software to the new owner of the property. In all cases the cost of replacing the malfunctioning systems would be prohibitively expensive.
