

Manville Water Supply Corporation CCN No. 11144; PUC Docket No. 51863

Pursuant to Texas Water Code § 13.257, the MANVILLE WATER SUPPLY CORPORATION ("Manville"), holder of Certificate of Convenience and Necessity ("CCN") No. 11144, hereby files this amendment to water CCN No. 11144 issued by the Public Utility Commission of Texas (the "PUC") in PUC Docket No. 51863 along with the CCN maps depicting and describing the new boundaries of the portions of water CCN No. 1114, and a boundary description by verifiable landmarks in accordance with Texas Water Code §13.257(r)(1)(c). It is the Manville's understanding that because the map filed herewith was developed by the PUC Commission Staff using the Texas State Plane Coordinated System, the map itself also satisfies the boundary description requirements in Texas Water Code §13.257(r) of the approximately 4.96 acres affected in the amendment. Accordingly, Manville submits the filed copy of the CCN map in satisfaction of the requirements of Texas Water Code §13.257(r) and (s).

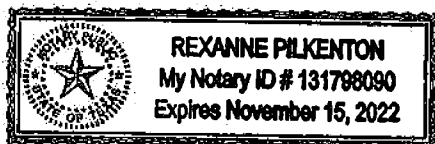

**Boundary Description of the Portions of Manville Water Supply Corporation's Water CCN Service Area
Amended by Order of the Public Utility Commission of Texas in PUC Docket No. 51863**

The following boundary description are only generally identify the subject surface area by verifiable landmarks in place at the time of this filing in accordance with Texas Water Code § 13.257(r)(1)(c).

The territory added to the area decertificated from Manville Water Supply Corporation and transferred to the City of Pflugerville's certificated service area are:

1. Approximately 4.96 acres previously certified to Manville Water Supply Corporation CCN No. 11144 removed from said CCN and singly certificated to the City of Pflugerville CCN No. 11303 located within the extra-territorial jurisdiction boundaries of the City of Pflugerville extra-territorial jurisdiction and generally bounded by the south, east, and west by the corporate boundaries of the City of Pflugerville and by the north by extra-territorial jurisdiction boundaries of the City of Pflugerville.
2. Manville Water Supply Corporaiton's modified service area boundaries are further depicted and described in the map developed by the PUC in attached hereto and for all purposes incorporated herein.

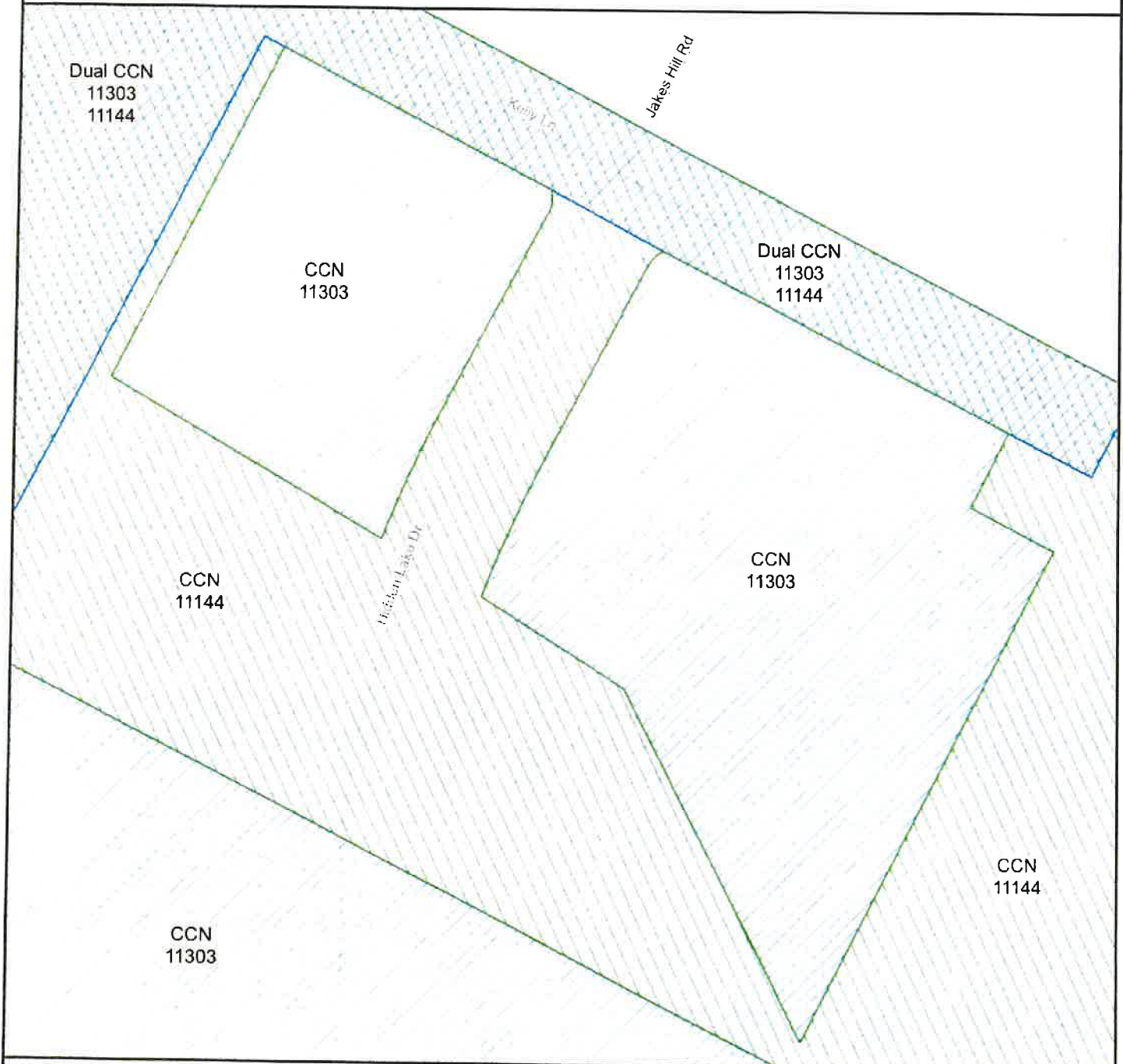
