COMMISSION STAFF’S REQUEST FOR EXTENSION

On March 2, 2021, the City of Midlothian (Midlothian) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11706 in Ellis County. Midlothian filed supplemental information on March 10, 2021 and April 19 and 21, 2021.

On April 1, 2021, the administrative law judge (ALJ) filed Order No. 2, requiring the Staff of the Public Utility Commission of Texas (Staff) to file its supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule, if appropriate, on or before June 2, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to finalize its supplemental recommendation on administrative completeness. Specifically, Staff filed a request for information (RFI) on May 25, 2021 to clarify Midlothian’s request for dual certification with Mountain Peak Special Utility District. Therefore, Staff respectfully requests that the deadline for Staff to file its supplemental recommendation and a proposed procedural schedule be extended to June 29, 2021.

II. CONCLUSION

Staff respectfully requests the issuance of an order extending the deadline for Staff to file its supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule, if appropriate, on or before June 29, 2021.
