COMMISSION STAFF’S SECOND REQUEST FOR EXTENSION

On March 5, 2021, the City of Woodway (Woodway) filed an application to amend its water certificate of convenience and necessity (CCN) 10022 and for dual certification with the City of Waco’s CCN number 10039 in McLennan County. The requested service area consists of 170 acres and 450 existing customers. Woodway filed supplemental information on May 10, 2021 and August 13, 2021.

On June 28, 2021, the administrative law judge filed Order No. 4, establishing a deadline of September 9, 2021 for the Staff of the Public Commission of Texas (Staff) to file a supplemental recommendation on the sufficiency of the application and propose a procedural schedule. Therefore, this pleading is timely filed.

I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is working with Woodway to determine if a CCN amendment is the application Woodway intended to file and requires additional time to review the application. Accordingly, Staff respectfully requests the entry of an order extending the deadline for Staff to file a supplemental recommendation on sufficiency of the application to October 8, 2021.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff’s deadline to file a supplemental recommendation on sufficiency of the application to October 8, 2021.
