COMMISSION STAFF'S REQUEST FOR EXTENSION

On March 16, 2021, Monarch Utilities I L.P. (Monarch) filed an application to amend its certificate of convenience and necessity (CCN) in Harris and Liberty Counties, Texas. Monarch holds water CCN No. 12893 and sewer CCN No. 20899. The requested service area consists of 121 acres and zero existing connections. Monarch filed supplemental information on May 13, 2021, July 28, 2021, February 14, 2022, March 4, 2022, May 10 and 25, 2022 and July 1, 2022.

On June 28, 2022, the administrative law judge (ALJ) filed Order No. 13, establishing a deadline of August 2, 2022 for Staff (Staff) of the Public Utility Commission (Commission) and Monarch (Collectively, the Parties) to file joint proposed findings of fact, including findings that address the factors in Texas Water Code § 13.246(c), and conclusions of law. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), Commission Staff may request that the time allowed for filing any documents be extended for good cause. Commission Staff is working with Monarch to draft the joint proposed findings of fact and conclusions of law. However, the Parties needs additional time to finalize the draft. Thus, Commission Staff respectfully requests an extension to August 16, 2022.

II. CONCLUSION

For the reasons discussed above, Staff respectfully requests the entry of an order extending its deadline for the parties to file joint proposed findings of fact including findings that address the factors in Texas Water Code § 13.246(c), and conclusions of law to August 16, 2022.
