#### **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On March 22, 2021, Quadvest, L.P. (Quadvest) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11612 and sewer CCN No. 20952 in Montgomery County, Texas.

On November 2, 2021, the administrative law judge (ALJ) filed Order No. 7, setting a deadline of November 8, 2021 for Quadvest to provide certain information to Staff for further processing of this matter. Additionally, Order No. 7 set November 29, 2021 as the deadline for the Staff (Staff) of the Public Utility Commission (Commission) to provide the final maps, certificates, consent forms, and tariffs (if applicable) to Quadvest for review and consent in this matter. Therefore, this pleading is timely filed.

#### I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is awaiting the receipt of additional information and documentation from Quadvest before Staff can provide the items due to be submitted to Quadvest. For instance, Quadvest has not yet submitted proof of approval of the distribution system. Therefore, the Staff respectfully requests that a deadline be set for January 7, 2022 for Quadvest to file the above-described items related to Staff's first set of requests for information (RFIs) filed on July 27, 2021. Additionally, Staff requests for the deadline to provide the consent forms and related items to Quadvest be extended until January 28, 2022.

### II. CONCLUSION

Staff respectfully requests that that a deadline be set for January 7, 2022 for Quadvest to file the above-described items related to Staff's first set of RFIs, and the deadline to provide the consent forms and related items to Quadvest be extended until January 28, 2022.
