On November 3, 2021, the Texas Commission on Environmental Quality (TCEQ) received planning material with your letter dated October 18, 2021 for the proposed distribution system - Decker Farms Section 1. Based on our review of the information submitted, the project generally meets the minimum requirements of Title 30 Texas Administrative Code (TAC) Chapter 290 - Rules and Regulations for Public Water Systems and is approved for construction.

The submittal consisted of 41 sheets of engineering drawings and technical specifications. The approved project consists of:

- Approximately 312 linear feet (lf) of 4-inch, American Society for Testing and Materials (ASTM) Standard D2241, Class 160, standard dimension ratio (SDR) 26, polyvinyl chloride (PVC) pipe;
- Approximately 835 If of 6-inch, ASTM Standard D2241, Class 160, SDR 26, PVC pipe;
- Approximately 4,773 lf of 8-inch, ASTM Standard D2241, Class 160, SDR 26, PVC pipe; and.
- Various valves, fittings, and appurtenances.

This approval is for the construction of the above listed items only. Any wastewater components contained in this design were not considered.
