**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On March 22, 2021, Quadvest, L.P. (Quadvest) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11612 and sewer CCN No. 20952 in Montgomery County, Texas.

On April 4, 2022, the administrative law judge (ALJ) filed Order No. 8, setting a deadline of April 22, 2022 for the Staff (Staff) of the Public Utility Commission (Commission) to provide a final recommendation or request a hearing. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff recently submitted a request for information in this matter.
