COMMISSION STAFF'S REQUEST FOR EXTENSION

On March 22, 2021, Quadvest, L.P. (Quadvest) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11612 and sewer CCN No. 20952 in Montgomery County, Texas.

On August 2, 2022, the administrative law judge (ALJ) filed Order No. 15, setting a deadline of September 1, 2022, for the Staff (Staff) of the Public Utility Commission (Commission) to provide a final recommendation or request a hearing. Staff apologizes for the untimely filing of this request for an extension.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Quadvest recently submitted proof of filing for a discharge permit application with the Texas Commission on Environmental Quality (TCEQ). The discharge permit is still being process by TCEQ. Therefore, in order to allow staff adequate time to coordinate with Quadvest regarding the approval of its pending TCEQ application and consider possible administrative options for how to most efficiently continue processing this matter, Staff respectfully requests that the deadline to provide a final recommendation be extended until September 23, 2022.

II. CONCLUSION

For the reasons outlined above, Staff respectfully requests its deadline be extended until September 23, 2022.
