COMMISSION STAFF’S REQUEST FOR EXTENSION

On March 22, 2021, Quadvest, L.P. (Quadvest) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11612 and sewer CCN No. 20952 in Montgomery County, Texas.

On September 9, 2022, the administrative law judge (ALJ) filed Order No. 17, setting a deadline of September 23, 2022 for the Staff (Staff) of the Public Utility Commission (Commission) to provide a final recommendation or request a hearing. Staff apologizes for the untimely filing of this request for an extension.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Quadvest recently filed a request to sever this docket into two distinct dockets due to a pending wastewater permit application at the Texas Commission on Environmental Quality (TCEQ). Specifically, Staff has coordinated with Quadvest to pursue a severance of the water portion of its application from the wastewater portion of its application into two distinct dockets. Therefore, Staff respectfully requests that the deadline to provide a final recommendation be issued in an order granting the severance described above.

II. CONCLUSION

For the reasons outlined above, Staff respectfully requests its deadline be extended within an order severing the dockets consistent with Quadvest’s recent filing.
