**ORDER NO. 37
RESPONDING TO REQUEST FOR CLARIFICATION
AND REVISING DEADLINES**

In light of Commission Staff's clarification filed on August 1, 2023, the administrative law judge (ALJ) adopts the following procedural schedule, which replaces the deadlines established in Order Nos. 35 and 36:

<u>Event</u>	<u>Date</u>
Deadline for Commission Staff to provide revised tariff, certificate, final map, and consent to Quadvest, LP	August 3, 2023
Deadline for Quadvest to respond to or file its consent to Commission Staff's revised tariff, certificate, and final map	August 10, 2023
Deadline for Quadvest to identify the location in the record of the capital improvement plan's keyed map and to clarify the purpose of its July 21, 2023 filing	August 10, 2023
Deadline for Commission Staff to file comments on whether Quadvest has satisfied the requirements of Texas Water Code (TWC) § 13.244(d)(3), consistent with the Commission's discussion at its October 6, 2022 open meeting ¹ and to file comments or a recommendation on Quadvest's July 21 and August 10, 2023 filings, if appropriate.	August 24, 2023

If Quadvest has not filed the capital improvement plan's keyed map, the following deadlines will apply:

The ALJ notes that while Commission Staff's response to Order No. 27 filed on March 31, 2023, briefly mentions the requirements of TWC § 13.244(d)(3), it does not appear that a recommendation was made on whether the requirements were satisfied.

Deadline for Quadvest to file the capital improvement plan's keyed map	August 24, 2023
Deadline for Commission Staff to file comments on whether Quadvest has satisfied the requirements of TWC § 13.244(d)(3), consistent with the Commission's discussion at its October 6, 2022 open meeting	September 7, 2023

The ALJ requests the parties seek the admission of any additional evidence into the record of this proceeding, as necessary.
