COMMISSION STAFF'S REQUEST FOR EXTENSION

On March 3, 2021, Aqua Texas, Inc. (Aqua Texas) and Parker County Special Utility District (PCUSD) filed a petition for a service-area contract under Texas Water Code (TWC) § 13.248 and to amend their water certificates of convenience and necessity (CCN) in Parker County related to the Estancia development. With this application, PCSUD agrees to transfer a portion of its water service area under CCN number 12313 to Aqua Texas under water CCN number 13201.

On May 3, 2021, Order No. 2 was filed, requiring parties to file joint proposed findings of fact and conclusions of law by July 14, 2021. This pleading, therefore, is timely filed.

I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff (Staff) of the Public Utility Commission of Texas (Commission) may request that the time allowed for filing any documents be extended for good cause. Staff requests additional time to review and resolve issues that arose during the drafting of the proposed order. Staff requests that the parties' deadline to file joint proposed findings of fact and conclusions of law be extended to July 28, 2021.

II. CONCLUSION

Staff respectfully requests the issuance of an order extending its deadline file joint proposed findings of fact and conclusions of law to July 28, 2021.
