**FINDING PETITION, AS SUPPLEMENTED, ADMINISTRATIVELY COMPLETE,
REQUIRING NOTICE, AND ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the March 30, 2021 petition of Aqua Texas, Inc. and Parker County Special Utility District for approval of a service-area contract under Texas Water Code § 13.248 and to amend their certificates of convenience and necessity in Parker County. On May 25, 2021, Aqua Texas and Parker County SUD filed a supplement to the petition. On June 28, 2021, Commission Staff filed a supplemental recommendation.

The administrative law judge (ALJ) finds the petition, as supplemented, administratively complete and proposed notice sufficient. The ALJ directs Aqua Texas and Parker County SUD to provide notice of the petition as described in the June 28, 2021 memorandum of Pai Liu attached to Commission Staff's recommendation, using the included forms.


The ALJ adopts the following procedural schedule as proposed:

Event	Date
Deadline for Aqua Texas and Parker County SUD to file an affidavit of notice	July 26, 2021
Deadline to intervene	30 days after notice is issued
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable) to Aqua Texas and Parker County SUD for review and consent	August 26, 2021
Deadline for Aqua Texas and Parker County SUD to file consent forms with the Commission	September 9, 2021
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the petition	September 16, 2021

If no hearing is requested, deadline for parties to file joint proposed findings of fact including findings that address the factors in Texas Water Code § 13.246(c), and conclusions of law	September 23, 2021
