ORDER NO. 5 FINDING PETITION, AS SUPPLEMENTED, ADMINISTRATIVELY COMPLETE AND NOTICE SUFFICIENT, ESTABLISHING PROCEDURAL SCHEDULE, AND RESTYLING

This Order addresses Commission Staff's July 13, 2021 corrected recommendation on administrative completeness and notice for Rodney Earl Mohnke, Stephen Lee Mohnke, Melvin Max Mohnke, Kenneth Wayne Mohnke, Kathleen Ann Mohnke-Blakely, and Mel Mohnke, Trustee of the Mohnke Living Trust Dated December 7, 1996's petition to amend H-M-W Special Utility District's water certificate of convenience and necessity number 10342 in Harris County by streamlined expedited release. The petitioners filed supplemental information on April 6, 2021, April 13, 2021, and May 27, 2021.

I. Finding Application Administratively Complete

Commission Staff recommends that the petition, as supplemented, be found administratively complete. The administrative law judge (ALJ) finds the petition administratively complete.

II. Finding Notice Sufficient

The petition includes notice to H-M-W SUD via certified mail return receipt requested. The ALJ finds that notice is sufficient.

III. Establishing Procedural Schedule

Under Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.

IV. Restyling Docket

Commission Staff requested that the style of this proceeding be revised to reflect that Mel Mohnke is the only trustee of the Mohnke Living Trust Dated December 7, 1996 and that Kenneth Wayne Mohnke is filing the petition on behalf of all of the parties who own an interest in the property for which release is requested.

The ALJ believes that a style similar to what petitioners listed in their April 1, 2021 petition is appropriate because it identifies all persons having an interest in the property (i.e., the petitioners) and that Mel Monke is the only trustee of the Monke Living Trust Dated December 7, 1996. The ALJ grants Commission's Staff's request to restyle the case to reflect that Mel Monke is the only trustee and restyles this proceeding as reflected in this Order.
